Don has substantial experience in complex civil litigation, real estate litigation, energy litigation, mining and mineral litigation, employment litigation, personal injury and product liability litigation. This experience includes antitrust claims, deceptive trade practices claims, partition suits, land use and development disputes, environmental litigation including claims of surface and groundwater contamination, firearms law, breach of contract disputes and declarations of contractual rights, tortious interference and other business torts. In addition, Don has represented both plaintiffs and defendants in personal injury litigation, including defense of wrongful death claims and product liability claims.

Don's substantial litigation experience includes:

- Representing as lead trial counsel a leading home improvement warehouse chain and obtaining a verdict and judgment for the client, which granted specific performance of a multi-million-dollar real estate purchase contract and awarded attorneys' fees.

- a host of claims including breach of lease.
- Defending landowners at trial and on appeal as lead counsel in a suit brought by real estate developers. Don obtained a defense verdict and defeated claims of specific performance, fraud and promissory estoppel.
- Acting as lead trial and appellate counsel for a family in bankruptcy court against bankrupt real
  estate developers. Don obtained judgment for his clients, which was affirmed by the U.S. District
  Court for the Western District of Texas, as well as the U.S. Court of Appeals for the Fifth Circuit.
