This award honors "a lawyer whose life and practice display sterling character and unquestioned integrity coupled with ongoing dedication to the highest standards of the legal profession." In 2010, the region's second Inn of Court was formed and named in honor of Lloyd Lochridge.

For Lloyd, pro bono work and community service are part of a lawyer's duty, as well as a personal joy. He continues to serve the profession through his practice and example, his activities in the bar, and his dedication to professionalism and to justice for all members of our society.
